MINUTES OF THE TOWN COUNCIL MEETING HELD ON 6 MARCH 2017

6866.	PUBLIC QUESTIONS: TOWN COUNCIL'S BANK AND PENSION PROVIDER. A resident asked which bank the Council uses and if it uses the County Council pension scheme. He was advised the bank account is with HSBC and the pension scheme is with Northumberland County Council. CAR PARKING IN HEXHAM. On behalf of approximately 20 Hexham businesses represented by people present, traders advised of the problems of parking in Hexham and the effect of this on their businesses. The Town Council was asked to consider their proposal to change the blue and white bays in the Wentworth car park to be valid for 6 hours and also bring back employers' permits valid for 10 hours. It was NOTED that the Town Council had a related meeting with County Council officers the next day, that this proposal would be discussed and that a meeting will then be arranged with the traders.
6867.	MARCH COUNCIL MEETING: Councillor T Cessford, the Town Mayor, then opened the Council meeting. Present were Councillors T G E Gillanders, Mrs C Hanley, M R Allan, J M Graham, Mrs C R Homer, T Robson, D Kennedy and D Clegg.
6868.	APOLOGIES FOR ABSENCE were received from Councillors P E Oliver, Dr N F Rose, S Ball, J V R Hare and G C Ferguson.
6869.	MINUTES: The minutes of the Town Council meeting held on 6 February 2017, having been circulated, were AGREED.
6870.	 a. OLD SWIMMING POOL AND HADRIAN HOUSE (Minute 6855 refers). It was noted that Mrs Dewison, Hexham Town Champion, had confirmed only that both properties are sold subject to planning. b. NORTHUMBRIAN WATER WORK AT TYNE GREEN (Minute 6863c refers). It was noted that this work has caused parts of Tyne Green to become a quagmire and it was AGREED to ask Northumbrian Water to lay some hardcore to assist. c. WEST COMMUNITY SAFETY HUB (Minute 6863f refers). It was noted that Inspector Bridges has advised of a focus on the night-time economy following successful investigations of some recent incidents. It was also noted that she will attend the Mayor's Spring Reception and looks forward to meeting Councillors, and is also planning some public events at the Police Station. d. ST CUTHBERT'S CLOSE (Minute 6863g refers). It was noted that the County Council's Strategic Planning Committee had agreed to have a site visit and that visit had been earlier on 6 March. The Committee would be considering the application on

	7 May and Councillor Cessford would speak at the meeting.
6871.	 MAYOR'S ANNOUNCEMENTS. For information Councillor Cessford advised the meeting: a. 3rd REGIMENT ROYAL HORSE ARTILLERY. He had attended a recent 3RHA function and is happy that a strong relationship is being built with Hexham. b. LITTER PICK. He noted there had been a strong turnout on 3 March for a litter pick in East Hexham. He also noted a Town Council arranged litter pick will take place between 10.00am and noon on Saturday 25 March, meeting in the Market Place, and that all are welcome. c. ROTARY CLUB YOUNG EMPLOYEE OF THE YEAR. He had attended these interviews. d. ST CUTHBERT'S. He was going to speak at the next day's Strategic Planning Committee regarding this application. e. MARKET PLACE. A meeting is pending regarding possibilities for the Market Place. f. CAR PARKING. A meeting is pending with County Council officers regarding possibilities for more car parking. g. CLERK'S RETIREMENT. He advised that, after 40 years' service, this was Mr Tiffin's last meeting as Clerk and thanked him for the work and advice given during that time.
6872.	DECLARATIONS OF INTEREST: No declarations of interest were made.
6873.	ACCOUNTS FOR PAYMENT: It was AGREED to authorise payments in accordance with the list that had been circulated and attached to the agenda. Councillor Robson requested that the hire purchase payments made for the tractor be considered at the next meeting of the Finance and General Purposes Committee, as the loan may be paid off. It was AGREED to put this on the agenda.
6874.	CORRESPONDENCE RECEIVED. (Note: wherever possible, all communications addressed to the Council are circulated to Councillors for information as and when received.) a. PLANNING ENFORCEMENT: Councillors had been circulated information from Northumberland County Council on its wish to raise the profile of its planning enforcement team. b. TEMPORARY TRAFFIC REGULATION ORDERS: Councillors had been circulated information on two orders. There will be possible delays in Market Street between 26 March and 9 April for the installation of a new mains electricity cable, and possible delays regarding resurfacing at Leazes Lane between 27 and 31 March. c. TYNE VALLEY RAILWAY USERS GROUP: Councillors had been circulated information on the TVRUG becoming a group member of the Community Rail Partnership for the Tyne Valley line.

	d. NORTHUMBERLAND RESIDENTS' FESTIVAL: Active Northumberland has provided leaflets to promote this Festival that allows residents to visit attractions in Northumberland at a free or discounted entry on the weekend of 1 and 2 April 2017.
6875.	TORCH CENTRE: Brian Massey, a trustee and member of the management committee, gave a presentation. He advised of the objectives relating to all disabled persons in the area and of the sports facilities provided. He advised the building is fully utilised but is 30 years old so a lot of maintenance is required. Noting the importance of raising the profile of, and funding for, the Torch Centre, Mr Massey spoke on different activities that take place, including a bar that is open two evenings per week. He listed many organisations that use the Centre and advised any support from the Town Council would be much appreciated, noting Grant Aid may be applied for.
6876.	PROPOSAL BY COUNCILLOR T CESSFORD: "That Hexham Town Council write to Northumberland County Council to ask them to change their decision to stop advertising, and public notices, in the Hexham Courant instead of now concentrating it in the Alnwick based Northumberland Gazette." This proposal was AGREED unanimously by the Councillors present.
6877.	STEWARD AND BAILIFF AWARD: It was AGREED that this year's award be given to Dave Hignett for his services to music in Hexham and Tynedale.
6878.	NEXT MEETING: The next meeting of the Council will be held on 3 April 2017 at 6.45pm at Dene Park House, Corbridge Road, Hexham.

Hexham Town Council Full Proposal from Councillor D Kennedy

Hexham Town Council recognises the new School Funding Formula will have perverse consequences for Hexham Schools. It is anticipated that by 2019 that the following schools will lose per annum:

- QEHS £521,000 12%
- HMS £176,000 9%
- Sele First £107,000 8%
- Hexham East First £32,000 6%
- St Joseph £124,000 8%
- St Mary £40,000 10%

In total Northumberland Schools - £17 million, the equivalent of £440 per student per annum.

The educational attainment of our children is vitally important.

Hexham Town Council calls on the Government, Secretary of State for Education and Hexham's MP to reconsider the funding formula and deliver fair financial settlement that:

- 1. ensures no child loses out as a result of the new formula
- 2. provides the funds necessary to give our children a good education
- 3. recognises that investment in education is an investment in the future of our children, our town, district and county.
